Tender notification

For supply of plastic docketts

Can Fin Homes Ltd, invites sealed tenders from the suppliers, who meet the following eligibility criteria, for printing and supply of 60,000 plastic docketts, for keeping loan documents :

- 1] Should have been in the line for 5 years.
- 2] Should have the capacity and infrastructure to print and supply 60,000 Plastic docketts within set time.
- 3] Should have reputed Companies and Banks in their list of clientele.

The suppliers who submit their offers will have to provide corporate profiles, credentials and also references from the buyers for whom the bulk supplies have been effected.

The specifications for the plastic docketts are given in the Annexure.

The suppliers have to submit their tender along with the samples of the docketts, as specified in Annexure, in one sealed cover. The Price Bid has to be submitted in another sealed cover super scribed as "Price Bid". The said two covers should be put in a larger cover super scribed "Bid for Supply of Plastic docketts".

After opening the tenders, the Company will screen the offers submitted by the suppliers who satisfy the eligibility criteria and shortlist the qualified suppliers. The samples of such short listed suppliers only will be considered by the Company for evaluation. The bids of such suppliers **whose sample is approved only will be considered by the Company for opening of price bid.**

The supplier who has quoted the least rate (L1) in price bid will be awarded the contract provided the Company is satisfied with the quality of the plastic docketts. The supply of docketts will be subject to the terms and conditions of Contract of Sale.

The printing/supply of plastic docketts shall be subject to the terms and conditions prescribed/to be prescribed by the Company and the Company shall be at liberty to reject the docketts, in the event of failure to comply with the terms and conditions set out in this letter.

The costs incurred by the applicant in making this offer, in preparing the sample docketts or in any of the process of this tender will not be reimbursed by the Company.

Please note that the Company reserves the right to accept or reject the quotations submitted depending upon the capacity of the suppliers. The Company also reserves the right to cancel the order at any point of time for the delay in supplying or for the non-compliance of terms and conditions stipulated by the Company. No dispute or negotiation shall be entertained in this regard and the decision of the Company shall be final and binding on all parties.
