Further, in the case of NBFCs-Middle Layer, this requirement can be relaxed by one level further. In view of the regulatory requirement, Mr. D R Prabhu, Deputy General Manager has been designated as the CCO.	Consequent to the proposal of designation of Mr. D R Prabhu, Deputy General Manager as the CCO in terms of the regulatory requirement (RBI Circular No.DoS. CO.PPG./ SEC.01/ 11.01.005/ 2022-23 dated April 11, 2022, Mr. R Madhu Kumar, Assistant General Manager has stepped down from the position of CCO.
