## **FAQ ON TAX ON DIVIDEND 2023-24**

The Finance Act, 2020 has abolished Dividend Distribution Tax and with effect from April 1, 2020 dividends declared by Indian companies would be taxable in the hands of shareholders. In the light of the above changes, under the Income-tax Act, 1961 (Act), companies paying dividend are required to deduct tax at the applicable tax rates (10% for resident shareholders with valid PAN), 20% for resident shareholders without PAN or invalid PAN and rates prescribed under the Act or Tax Treaty, read with Multilateral Instruments, if applicable, for non-resident shareholders). No TDS is applicable if the dividend payable to resident individual shareholders having valid PAN is less than Rs.5,000 p.a.

The following is the shareholder's classification for the purpose of determining the applicability of TDS on Dividend:

### 1. Resident Individual Shareholder with valid PAN:

- If any resident individual shareholder is in receipt of dividend exceeding Rs. 5,000 in a fiscal year, entire dividend will be subject to TDS @ 10%. The rate of 10% is applicable provided the shareholder has updated his/her PAN with the depository/ Registrar and Transfer Agent (RTA). Otherwise the TDS rate will be deducted at 20%.
- If the dividend to a resident individual shareholder does not exceed Rs 5,000 in a fiscal year, no TDS is applicable.
- If the resident individual shareholder provides declaration in Form <u>15G</u>/ Form <u>15H</u>/Tax Exemption Certificate, no TDS is applicable.
   Form 15G/Form 15H enclosed as <u>Annexure-I</u>

## 2. Resident Non-Individual Shareholder (HUF, Firm, AOP, BOI, Company):

The entire dividend will be subject to TDS for non-individual resident shareholders without any threshold limit. The tax deduction rate will be 10% provided a valid PAN is updated with the company or the depository/ RTA. Otherwise the TDS rate will be 20%. In case of resident non-individual shareholders, if the income is exempt under Section 10 the Act, the authorized signatory shall submit the declaration duly signed with stamp affixed for the purpose of claiming exemption from TDS. Self-Declaration enclosed as Annexure-II

### 3. TDS applicable to Insurance Companies:

TDS is not applicable on the dividend paid to the insurance companies in case it provides a self-declaration that the shares are owned by it and it has full beneficial interest along with a self-attested PAN and registration certificate issued by IRDAI. Self-Declaration enclosed as Annexure-II.

## 4. TDS applicable to Mutual Funds:

TDS is not applicable on the dividend paid to a Mutual Fund specified under clause (23D) of section 10 of Income Tax Act, 1961. Such Mutual Fund should provide a self-declaration that they are specified in Section 10 (23D) of the Income Tax Act, 1961, self-attested copy of PAN card and registration certificate. Self-Declaration enclosed as Annexure-II.

## 5. Alternative Investment Fund (AIF) established in India:

A declaration that its income is exempt under section 10(23FBA) of the Act and they are established as Category I or Category II AIF under the SEBI regulations. Copy of

registration documents (self-attested) and PAN should be provided. Self-Declaration enclosed as Annexure-II.

**6. Beneficial Ownership**: In case of equity share(s) held in the Company as a beneficiary; and are not subject to TDS under Section 196 of the Act, the person shall submit self-attested copy of the documentary evidence supporting the exemption status along with self-attested copy of PAN Card.

**7. Benefit under Rule 37BA**: In case where shares are held by intermediaries/stock brokers and TDS is to be applied by the Company in the PAN of the beneficial shareholders, then intermediaries/ stock brokers and beneficial shareholders will have to provide a declaration. Declaration under Rule 37BA enclosed as **Annexure III** 

## 8. <u>TDS applicable to Foreign Institutional Investors (FIIs) and Foreign Portfolio</u> Investors (FPIs):

TDS shall be deducted @ 20% (plus applicable surcharge and cess) on dividend paid to Foreign Institutional Investors ("FIIs") and Foreign Portfolio Investors ("FPIs") in view of specific provision under section 196D of the Income tax Act 1961.

Please note that there is no threshold provided for which no tax will be withheld. Entire dividend is subject to withholding of tax.

Cess shall be applicable at 4 % on surcharge as above.

### 9. TDS applicable to non-resident shareholders other than FIIs/ FPIs:

For non-resident shareholders, the rate of TDS is 20% (plus applicable surcharge and cess) as per Indian Income- tax Act, 1961. However, where a non-resident shareholder is eligible to claim the tax treaty benefit, and the tax rate provided in the respective tax treaty is beneficial to the shareholder, then the rate as per the tax treaty would be applied. In order to avail tax treaty benefits, non-resident shareholders would be required to submit the below documents:

- Self-attested copy of Permanent Account Number (PAN Card), if any, allotted by the Indian income tax authorities;
- Self-attested copy of Tax Residency Certificate (TRC) for FY 2023-24 obtained from the tax authorities of the Country of which the shareholder is resident;
- Electronically submitted Form 10F as per Central Board of Direct Tax (CBDT) issued Notification No. 3/2022 on 16th July 2022 under the Income Tax Act (ITA).
- Self-declaration by the non-resident shareholder of having no permanent establishment in India in accordance with the applicable Tax Treaty;
- Self-declaration of beneficial ownership by the non-resident shareholder. Self-Declaration enclosed as Annexure-IV

Please note that the Company is not obligated to apply the beneficial DTAA rates at the time of tax deduction/withholding on the dividend amount. Application of beneficial DTAA Rate shall depend upon the completeness and satisfactory review by the Company, of the documents submitted by the non-resident shareholder.

If the documents are not provided or are insufficient to apply the beneficial DTAA rates, then tax will be deducted at 20% including surcharge and cess @ 4%.

## Dividend will be paid after deducting the tax at source as under:

- > NIL for resident individual shareholders receiving dividend upto Rs.5000 in aggregate in a Financial Year (i.e., FY 2023-24) or in case Form 15G / Form 15H (as applicable) along with self-attested copy of the PAN is submitted
- > 10% for resident shareholders in case PAN is provided/available for those not covered above
- > 20% for resident shareholders, if PAN is not provided / not available
- ➤ Lower/ NIL TDS on submission of self-attested copy of the certificate issued under section 197 of the Income Tax Act, 1961.
- > 20% plus applicable surcharge and cess for non-resident shareholders in case the aforementioned documents are not submitted
- > Tax will be assessed on the basis of documents submitted by the non-resident shareholders
- > Further, Shareholders who are required to link their Aadhaar number with their PAN in terms of the provisions of Section 139AA(2) read with Rule 114AAA of the Act, should link the same. For dividend amounts are payable after September 30, 2021 and PAN of shareholder is not linked with Aadhaar, then such PAN will be deemed to be invalid and TDS will be deducted at higher rates u/s 206AA of the Act.
- > Further tax deducted at source (TDS) rates for dividend prescribed under the Income Tax Act ('Act') are subject to the provision of section 206AB of the Act (effective from July 1, 2021) which introduces special provision for TDS in respect of non-filers of Income Tax returns. For the prescribed rates for various categories, the Shareholders are requested to refer to the Finance Act, 2020 and amendments thereof.
- According to the provisions of section 206AB, a specified person means a person who has not filed their returns of income for two years immediately preceding the year in which tax is required to be deducted and the aggregate of tax deducted at source and collected at source is rupees fifty thousand or more in each of these two years. Accordingly, applicable tax deduction rates for specified person would be twice the prescribed rates. For Resident specified shareholder it would be 20% and for Non-Resident specified shareholders (who has not furnished a declaration stating no

permanent establishment in India) the tax deduction rates would be 40% plus applicable surcharge and cess as prescribed under the Act.

## > <u>Timeline to submit the documents for claiming concessional rate benefit under the Treaty:</u>

All the above-mentioned documents should be sent to <a href="mailto:investor.relationship@canfinhomes.com">investor.relationship@canfinhomes.com</a> on or before December 30, 2023. Failure to do so, will attract TDS at the applicable rates as mentioned in the above paragraphs.
